## CHS now offering night school classes

This year Conway is changing how students can earn back missed credits. Night school is now offered to students of the Laclede County R-1 School District.

Students who have failed a required course and lack standard credits needed to graduate will be offered the opportunity to earn those credits back in order to graduate on time. Students must complete a minimum number of sessions or a student may finish the academic work sooner, but they must complete the required seated time.

The courses offered during the night school program are not for students to get ahead.

"We want to keep students on track to graduate with their class. We also want to prevent students from taking freshmen or sophomore-level courses during their senior year because they failed

school. Our goal is that all juniors and seniors are on track to graduate and take dual credit courses, participating in Greater Ozarks Center for Advanced Professional Studies (GOCAPS), or earning a certification through LTCC," said Conway High School Principal Jaymes Wapp.

There are two opportunities to earn back those credits while in the night school program. There is credit recovery and credit acquisition available to


Credit Recovery is only offered to students who failed the class within 10 percent of passing grade (50-59 percent). Students who will be in credit recovery will be allowed to pass with a Dgrade and receive onehalf credit after completing the required course.

Credit Acquisition is for students who failed the class with below 50 percent. Students who failed the course with

a course early in high a 50 or below will be taking an online class through the Launch Program. If students complete the online course with a minimum of 80 percent, they will receive one-half unit of credit. Students cannot miss more than 6 sessions in a row, or they will be dropped from the roster and removed from night

With night school offering students the opportunity to earn credit from a previously-failed course, students now have one semester and summer school to complete the required course. Îf students do not recover the course in this time frame, they will have to completely retake the course.

The school will be offering night school Monday through Thursday from 3:30 to 4:30 p.m. Mrs. Spradling and Ms. Vestal are now working with students to help them recover credit from the Fall 2019 semester.
